

# Largs Sailing Club – House Memberships

Are you interested in sailing - or just watching others involved in this great sport? Or maybe you own a boat - *but* your boat isn't berthed in Largs Yacht Haven, and you want to use the club socially?

We offer our members and their guests:

- a large clubhouse, with the **best view in the marina** from our club lounge, and balcony.
- our **Lookout Bar / Lounge**, where members can meet with friends, family and other Club members, for a drink, bar snacks, tea and coffee, and a chat. **Free wi-fi**.
- **opening hours** are seasonal, and are on the web site. Open 7 days in summer.
- regular **social events** and **themed evenings** e.g. monthly quiz nights, talks, and dances
- members can also **hire rooms** for private events – sailing or business meetings, birthday parties, anniversaries – even weddings can be held in our fantastic setting.

We offer **house and joint house** (“social”) membership to anyone who has an interest in the Club’s objectives i.e. encouraging all forms of sailing, motor boating and other water based activities, and related social activities.

**House members** (£57, or £65 with newsletters by post) are members who do not normally go afloat (except as LSC volunteers), *and* are not owners or part owners of a boat berthed in LYH for any part of the year. They are entitled to take an active part in the onshore activities of the Club, and make full use of the facilities provided by the clubhouse. We also offer **joint house membership** (£78 / £86 with newsletters by post), which **includes partner**, who may use the clubhouse separately to the named member. House / joint house members have no vote, have no dinghy sailing or berthage entitlement, and do not receive a discount card.

Largs SC is a private members club, and only members and their guests can use the facilities. Guests must be signed in, and are limited to 5 visits per year.

Prospective members are very welcome to come into the clubhouse to see what we offer, and talk to our administrator Julia in the office, or club steward Avril Leslie at the bar, upstairs.

To apply for membership, please fill in the details on the other side of this sheet, and drop it into the Largs SC office (ground floor, to the sea side of the porch – use letter box if office closed), with your fee, or pay at the bar by card or cash (N.B. if you pay at the bar, please ask for the till receipt to be attached to this form, to ensure your payment is properly recorded) - or you can **apply (and pay) on line** - see <https://webcollect.org.uk/largssc/>.

Please note that other categories of membership are available, from junior and crew membership, up to family membership, which entitles your children to join the very popular LSC / LSTA cadet training scheme. Before opting for this, please check with the Club that junior training spaces are available.

# Largs Sailing Club Membership, and Data

New, more stringent Data Privacy and Protection regulations ("the GDPR") came into force on 25th May 2018, and we require all new and current members to signify their consent (or otherwise) to the matters below. The key points are that:

- the information you provide in your membership application form, or on WebCollect, will be used solely for dealing with you as a member of Largs Sailing Club
- we will NOT share your information with any third party without your specific consent
- you now have to positively opt IN to certain uses of your data.

### **1. Membership conditions**

By applying for membership, and continuing your membership, you consent to:

- **storage and processing of member's data** - your data being stored on a computer database (presently WebCollect)

- **insurance whilst racing** - when racing, boats must have third party insurance to the value of at least £2,000,000.00
- **communication with members** - our normal method of communications with members is by e-mail. Members not giving at least one valid e-mail address per membership must pay the supplement (presently £8) for communications by post.

### **2. Date of birth**

Older members may give their date of birth, but we require **all members under 25 on 1st January** (the limit for junior membership) in the subscription year (Jan-Dec) to give their date of birth. Also, we need to know the parent or guardian of members under 16, please.
